## **Committee and Board Updates**

**Proactive Zoning Enforcement**-Jonathan Erickson reported that Julie Bricksman is bringing a motion not to have proactive zoning enforcement. He stressed the importance of completing the survey and maintaining pressure on Phyllis Randall. The Loudoun County meeting is scheduled for September 16th. Members were advised to sign up early on the Friday morning before the meeting (8:30 a.m.) to speak.

**Hidden Lane Landfill**-Jonathan Erickson reported that a meeting with the County, EPA, and DEQ regarding the 90-acre sale to Loudoun County had occurred, but the sale was not finalized. Status is "in limbo."

**Community Signs**-An issue was raised regarding signs falling over. Roy suggested using two wire stakes per sign, placed at each end, and ensuring they are planted deep enough (using a rebar tool to pre-drill if necessary).

### **Trailer Storage**

Discussion held regarding use of new trailer for BRFC property.

**Motion:** To pay Bee Jay and Colleen Glosson \$200 a year for the rental and storage of the trailer.

### **Oktoberfest Planning**

**Kayak Storage**-Suggestion made to enclose the bottom of the existing structure. Action tabled until after trailer inventory.

**Red Flag Notices-**Roy clarified that a Red Flag Warning means the fire pit must remain closed due to weather conditions.

**Sale of Chairs-**Susan Cleveland offered 8 folding chairs at \$5 each. Action tabled until after trailer inventory.

**Website Updates-** Sarah Oberther presented the new BRFC website, which supports online payments, membership management, reservations, e-blasts and a merchandise store.

**Email Alias-** Roy suggested shortening the association email address. Sarah will look into alternatives.

**Fire Hydrants and Insurance-**A member asked if hydrant installation in only part of the neighborhood could affect insurance rates.
